21-1 Limitation of speed

No person shall operate a motor vehicle or a motorcycle upon any public highway within the corporate limits of the Village of Hilton at a rate of speed in excess of thirty (30) miles per hour. This section shall not apply to ambulances, fire vehicles or police vehicles when on emergency trips.

21-2 Prohibition of all-night parking

(Amended 4-3-72)

No vehicle shall be parked on any public highway within the corporate limits of the Village of Hilton between the hours of 12:00 midnight and 6:00 a.m. during the period beginning November 1 and ending April 1 of each year.

21-3 Parking restrictions (Amended 9-13-71)

- A. No vehicle shall be parked on Main Street, Route 18, or on any public or state highway within the Village of Hilton other than parallel to the edge of the street, headed in the direction of traffic, and with the front and rear wheels not more than six (6) inches from the curb.
- **B**. There shall be a limit of one-hour parking on the following streets:
 - (1) Main Street, both sides.
 - (2) South Avenue, both sides, from Main Street to Hazen Street.
- **C**. There shall be a limit of forty-eight (48) hours parking in one spot in all village parking lots.

21-4 Prohibition of parking in designated location

- **A.** The parking of vehicles in any of the following locations is hereby prohibited:
 - (1) It shall be illegal to park vehicles on Hovey Street as follows: west side of Hovey Street from Main Street north one hundred forty (140) feet; east side of Hovey Street from Main Street north four hundred fifty (450) feet. (Added 4-7-58)
 - (2) Parking shall be prohibited at hours of the day and night on the south side of Hazen Street throughout the entire length of the street. (Added 7-6-59)
 - (3) Parking shall be prohibited at all hours of the day and night on the north side of East Avenue from the Penn Central Railroad to Hovey Street. (Added 2-6-67)
 - (4) East side of Lake Avenue from Main Street to entrance of parking lot. (Added 9-13-71)
 - (5) North side of Main Street from Lake Avenue east twenty (20) feet. (Added 9-13-71)
 - (6) West side of South Avenue from Main Street south to the bridge. (Revised 10-3-88)
 - (7) East side of South Avenue from Village II Drive north to the bridge. (Added 9-9-74)
 - (8) Both sides of Village II Drive from South Avenue to the entrance of Village II Apartments. (Added 9-9-74)
 - (9) West side of Lake Avenue between 193 Lake Avenue and 109 Lake Avenue. (Added 10-10-74)
 - (10) West side of Mariah Street from West Avenue to Brook Street. (Added 7-7-75)
 - (11) Both sides of Cedar Terrace from South Avenue to 305 Cedar Terrace.
 - (12) Both sides of the following streets: (Added 1-3-77)
 - (a) Bernie Whelehan Road North.
 - (b) Bernie Whelehan Road South.
 - (13) Parking shall be prohibited at all hours of the day and night on both sides of Parkwood Lane for the entire length of the street. (Amended by Local Law 4 1996)
 - (14) All areas designated for use by handicapped persons, except for vehicles in which a handicapped person is either a driver or a passenger. (Added 10-19-81 by L.L. No. 7, 1981)

21-4 Prohibition of parking in designated location

- (15) On Henry Street during Community Center activities as follows: east side of Henry Street from the intersection of West Avenue to the intersection of Grove Street; west side of Henry Street from the intersection of Grove Street south for one hundred twenty (120) feet.
- (16) On Henry Street as follows: west side of Henry Street from the intersection of West Avenue north a distance of sixty (60) feet.
- (17) There shall be a limit of fifteen- minute parking on the west side of Henry Street from a distance of three hundred ten (310) feet north from the intersection of West Avenue to a distance of three hundred ninety (390) feet.
- (18) On Gorton Avenue, both sides, during Community Center activities.
- (19) On the east side of South Avenue, from a point 50 feet north of the curb line of Hillside Drive to a point of 100 feet south of the curb line of Cedar Terrace. (Added 6-2-86).
- (20) On the west side of South Avenue, from a point of 50 feet north of the curb line of Overlook Drive to a point of 100 feet south of Cambridge Road. (Added 6-2-86)
- (21) No parking shall be allowed on the east side of the building at 1 East Avenue. (Added 9-9-85)
- (22) Parking is prohibited on both sides of Rolling Meadows Drive North from house #4 thru house #12.
- (23) No parking on the north side of East Avenue from the intersection of Bennett Road west to the intersection of Fraser Drive. (Added 10-3-88).
- (24) No parking on the west side of Bennett Road from the intersection of East Avenue north to the entrance road to the Hilton Central High School. (Added 10-3-88)
- (25) No parking and no standing on both sides of Fraser Drive, Cooper Drive and Tyler Trail during school days from 7:00 A.M. thru 4:00 P.M. (Added 12-4-89; amended 1/4/05)
- (26) No parking on the north side of East Avenue from the intersection of Fraser Drive west to the intersection of Short Hills Drive.
- (27) No parking on the south side of East Avenue from the intersection of Short Hills Drive east to the Village corporation line.

21-4 Prohibition of parking in designated location

- (28) Parking shall be prohibited at all hours of the day and night on both sides of Park Square for the entire length of the street from November 1st through April 1st each year. (Added 11/4/96 by Local Law No 5 1996)
- (29) Both sides of Old Hojack Lane for the entire length of the street. (Added 11/2/98)
- (30) Parking shall be prohibited at all hours of the day and night on the north side of Peach Blossom Road North between house #50 through #62. (Added 3/16/99)
- (31) No parking and no standing on both sides of Short Hills Drive, Little Tree Lane, Sunny Slope Drive, Mockingbird Lane, Turtle Creek Lane and Efner Drive on school days between the hours of 7:00 A.M. thru 4:00 P.M. (Added 1-7-2003; amended 1/4/05)
- **B**. The parking of vehicles in any of the following locations is hereby prohibited during church services:
 - (1) North side of Gorton Avenue from Lake Avenue to No. 24 Gorton Avenue.
 - (2) North side of West Avenue from Lake Avenue to No. 46 West Avenue.
 - (3) East side of Lake Avenue from No. 144 Lake Avenue to No. 182 Lake Avenue.
 - (4) South side of East Avenue from the New York Central Railroad to Canning Street.
 - (5) West side of Lake Avenue from the Penn Central Railroad to West Avenue. (Added 9-13-71).
 - (6) The parking of vehicles is hereby prohibited during church services on the north side of East Avenue from the east property line of house No. 118 East Avenue west to Railroad Avenue. (Added 6-2-58).

A. The following intersections are hereby designated as stop intersections and stop signs shall be erected on entrances thereto as follows: (Revised 2-17-87; 2-6-89; 12-4-95, 6/10/96, 12/8/97; 11/2/98; 11/7/00)

21-6 Repeal of prior ordinances

All ordinances or parts of ordinances of the Village of Hilton inconsistent with the provisions of this ordinance are hereby repealed; provided, however, that such repeal shall be only to the extent of such inconsistency, and in all other respects this ordinance shall be in addition to the other ordinances regulating and governing the subject matter covered by this ordinance.

21-7 Penalty for speeding violations

Any person or persons violating any of the provisions of 21-1 of this ordinance shall, upon conviction, be punishable by a fine not to exceed one hundred dollars (\$100.00) or by imprisonment not to exceed thirty (30) days, or both such fine and imprisonment.

21-8 Penalty for stop sign violations (Added 4-3-72)

Any person or persons violating 21-5 of this ordinance shall be punishable for the offense by a fine not to exceed ten dollars (\$10.00), and for the second offense within one (1) year by a fine of not less than ten dollars (\$10.00) nor more than twenty-five dollars (\$25.00) or by imprisonment for not less than two (2) nor more than fifteen (15) days. The third or any subsequent offense within one (1) year shall be punishable by a fine not exceeding one hundred dollars (\$100.00) or by imprisonment not exceeding six (6) months, or by both such fine and imprisonment.

21-9 Penalty for parking violations

(Amended 4-3-72; 10-19-81 by L.L. No. 7, 1981; 10-7-85 by L.L. No. 2, 1985;2-6-89; 2-3-97 by L.L No. 1, 1997)

The owner of any vehicle illegally parked in the Village of Hilton or any person or persons otherwise illegally parking in the Village of Hilton shall be guilty of an offense. The penalty for parking violations shall be as follows:

- A. Parking in areas designated for the handicapped; Fifty dollars (\$50.00). (Amended Feb 97)
- **B**. Parking in areas designated as fire lanes or in no-parking areas adjacent to hydrants: fifteen dollars (\$15.00). It is intended that the storing of any containers, receptacles or other material designated as a fire lane or fire zone shall constitute a parking violation.
- **C.** All other parking violations; fifteen dollars (\$15.00).
- A conviction of a third or subsequent parking violation of any nature, all of which were committed within a period of 18 months; Fifty Dollars (\$50.00).
 (Added 2/3/97 by Local Law No 1 1997)

12-10 Fire Lanes (Added 11-4-74)

- A. The Chief of the Fire Department and/or the Building Inspector, subject to the approval of the Village Board, shall designate a traffic lane or other area designated for use by fire or other emergency vehicles on any street, driveway or parking area.
- **B**. It shall be a violation of these regulations to park any vehicles or store any containers, receptacles or other material within any area adjacent to a hydrant or within any lanes or areas designated as a fire lane or fire zone in the Village of Hilton. (Amended 10-19-81 by L.L. Nov. 7, 1981).
- C. Anything contained in this ordinance or any other applicable law to the contrary notwithstanding, any vehicle parked in violation of this regulation shall be towed away by the Village of Hilton and stored at the expense of the owner, which expenses shall be paid prior to the redemption of the vehicle.

21-11 Modification of penalties

(Added 10-19-81 by L.L. No. 7, 1981)

The Village Board may, from time to time, on public notice, modify the penalties herein established.

21-12 Abandoned Vehicles (Added 2-3-97 by L.L. No. 1, 1997)

The Village Administrator may remove and store or cause to be removed and stored any vehicle parked or abandoned on any public highway within the corporate limits of the Village of Hilton during snowstorms, floods, fires or other public emergencies, or found unattended where they constitute an obstruction to traffic or any place where stopping, standing or parking is prohibited and the owner or operator of any such vehicle shall be responsible for payment of any and all reasonable charges for such removal and/or storage.
