INVESTING IN THE FUTURE OF THE HILTON COMMUNITY

The Hilton community can be proud of the combined efforts of the Village, Town, School and Fire District in their efforts to implement a shared salt storage facility. For many years now, the Town, Village, School and Fire District have been sharing resources, equipment, materials and manpower. Now, with the support of each governing board, the public will see a solid symbol of that collaboration in the structure that will be built and shared between all. The facility will improve the efficiency and cost effectiveness of combined services provided to the community. Not only will the facility provide much

greater storage capacity, but the structure will also improve environmental issues caused by the current facilities in use by the town and the village.

Construction on the new facility at 40 Grove Street, is scheduled to begin in May with a projected completion date in September. Drainage and site work is being done by the town and village.



The investment the village has made to rehabilitate the property at 10 Canning Street, where the old co-op building previously sat, before being destroyed by fire, is now coming to fruition. By pulling out the old concrete foundation

slab, adding new roads, gutters, curbing and sidewalks and relocating and upgrading electrical services, the property was able to be sold and developed into the new construction that is currently underway to house the Hilton Family Dentistry practice, presently located on South Avenue, in the Tops Plaza. The new building will greatly enhance the previously vacant site and put the property to good, productive use again.

ANNUAL VILLAGE BUDGET FOR 2013-14 FISCAL YEAR

The new budget adopted by the Village Board that goes into effect on June 1, 2013, through May 2014, shows a 2% increase in the tax rate, rising .05 cents over the previous years rate of \$2.53 to the new rate of \$2.58 per \$1,000. The increase falls within the Governor’s tax cap limit.

The new budget includes \$143,000 to be allocated into an equipment reserve fund. The fund will be used in 2014 to purchase a new refuse truck. \$57,000 will be used to purchase 2 new pick-up trucks for the Department of Public Works. \$140,500 is reserved for road maintenance including milling, slurry sealing and paving of both Peach Blossom North and Peach Blossom South and \$22,000 will be used for sidewalk and gutter repair and or replacement along Peach Blossom North. \$59,000 will go toward the new construction of the salt storage facility. \$6,100 will pay for a new security camera to be installed on the first floor of the Community Center for added safety.

In this year’s budget, a provision was made for a special disaster recovery plan. In the recovery plan, \$10,800 will be used to purchase a new and totally separate computer server that will be

located in the Department of Public Works facility. This server will house a complete back-up system of all the programs, data, and history on the current system located in the Community Center. In the case of an emergency or disaster that prevents access to the current server, this new system will provide a back-up to access important data in a separate location.

Included in the projects of the Department of Public works is the continued rehabilitation of our sewer system. The sewer along parts of South Avenue, Smith Street, Hazen Street and East Avenue, between Railroad Avenue and Main Street, will have improvement work done. There will be no rate increase for these sewer upgrades during this fiscal budget year.

Additionally, 1/3 of the Community Center roof is in need of repair. The money needed for the repair will come out of the current budget year and will not affect the 2013-14 budget.

There will be an increase in the daily charge for water from .13 cents a day to .15 cents a day. The consumption charge will remain the same at \$2.77 per thousand gallons.

HILTON CELEBRATES 100 YEARS OF SCOUTING

Not many communities in the United States can boast 100 years of continuous Boy Scout activity. Hilton is one of the rare exceptions.

Hilton's record for Boy Scouting began back in 1913 when newly arrived Baptist minister, Harry Greensmith arrived from England, bringing the Boy Scout concept with him. The Scouting idea was presented gaining unanimous support, as has been supported ever since.

The idea of Boy Scouts was the brainchild of Sir Robert Baden-Powell, a British Military Officer who had been on numerous expeditions in India and the Middle East in the 20th century. He was a hero to young British lads who thirsted for adventure and challenge.

The first Scouts in Hilton were members of Lookout Mountain Patrol number 2 of Monroe Company. 11 boys joined the troop and memorized the scout motto, oath, and laws. Their first event was an overnight cookout at the Braddock Point Lighthouse at Lighthouse Beach.

In a few years the Hilton troop was known as Troop 1, and then around 1917 the name was changed to Troop 99 with Mr. John Way as the Scoutmaster. Troop 99 is still very active today after 94 years.

Over the years, interesting

trips were arranged for older Scouts to places like Pike's Peak and Camp Philmont. Many former Scouts can recall summers spent at camps Massawepie, Corey, and Cutler.

The Scouting leadership, offered by men such as Rev. Greensmith, John Way, Lewis Archer, Leonard Wright, Frank Pickett, and numerous others, stands as testimony to the quality of citizens residing in the Hilton community. During Scoutmaster Archer's tenure in the 1930's more merit badges were earned in Hilton than any other post in the county. Mr. Archer also revived the ancient skill of archery in his troop and published articles on its history that syndicated through the national press, and helped revive this almost unused skill among Boy Scout Troops of the U.S.

Today Troop 99, and troop 125 along with Cub Scout Packs 99, 125 and 330 are active in the Hilton Community.

The Scout Motto: "*Be prepared*". The Scout Oath, "*To do my duty to God and my country, and to obey the scout law; to help other people at all times; To keep myself physically strong, mentally awake, and morally straight*".

The Hilton community can be proud of its 100 years of scouting history, and the many scouts who have distinguished themselves with the Eagle Scout Award through diligence, perseverance and hard work. This is a year to honor all our local scouts and encourage them in their endeavors. ■

THE VILLAGE OF HILTON CURFEW LAW

As a courtesy reminder to the community, village officials would like to restate that the Village of Hilton has a curfew law and would like to explain what that means to youth in the Village of Hilton.

In December of 1991, The Hilton Village Board adopted a curfew law for the purpose of reducing juvenile crime and vandalism and to protect the children of this municipality and reinforce parental authority to keep minors out of public areas after dark.

The curfew law states that it is unlawful for any child age 17 or under, to remain in or upon any public street, sidewalk, highway, park, vacant lot or other public place starting at 11:00 p.m. Sunday thru Thursday and ending at 5:00 a.m. The next day; and starting at 11:59 p.m. Friday and Saturday and ending at 5:00 a.m. The next day.

There are a few exemptions to the law as follows.

- ★ (A) At any time, if the child is accompanied by his or her parent, legal guardian or other responsible person who is over the age of twenty-one and approved by the child's parent or legal guardian;
- ★ (B) if the child is legally employed, for the period from one-half hour after work, while going directly between his or her home and place of employment. This exception shall also apply if the child is in a public place during curfew hours in the course of his or

her employment. To come under this exception, the child must be carrying a written statement from the employer attesting to the place and hours of employment;

- ★ (C) If the child is coming directly home from a school activity or an activity of a religious or other voluntary association, or a place of public entertainment, such as a movie, play or sporting event. This exception will apply for one-half hour after the completion of such event, but in no case beyond 1:30a.m.
- ★ (D) If the minor is exercising first amendment rights protected by the Constitution, such as the free exercise of religion, speech, or assembly, provided the minor first has given notice to the Administrator by delivering written communication signed by the minor and countersigned by a parent of the minor which specifies when, where, in what manner, and for what first amendment purpose the minor will be on the streets at night during the curfew period.

Failure to comply with this law shall be a violation of the New York State Penal Law and penalties may be imposed.


