#### PLANNING SEGMENT - SITE PLAN - 6 & 9 UPTON STREET

Application of Engels Gualdani, to construct a new building, proposed sized 52'x100' on parking area. Property is zoned Industrial. Village Board has given approval for the subdivide at their 8-4-20 meeting.

Larry Heininger, engineer for Marques & Assoc., P.C. presented to the Board the proposed construction of a new building (approx. 52' x 100') on the existing parking lot. Proposed use is for automotive. Public water is on site and public sewer is at the rear of the parcel. Currently, Mr. Gualdani owns and occupies 6 Upton Street for an automotive sales and storage business.

Member Holenbeck asked if there would be any landscaping around the exterior. Mr. Gualdani stated landscaping would be kept simple, as it is at 6 Upton Street

Member Weaver inquired about lighting and signage. Mr. Gualdani stated there will be directional lighting that will go out approximately 50' then angle downward. Signage may consist of some lettering on the building with the lighting reflecting on it.

Linda Viney mentioned what a great asset Engels is to our community.

Code Enforcement Officer, Mark Mazzucco read through the Environmental Assessment Form as filled out by the applicant. Interim Chairman Weaver asked for a motion to declare the Planning Board as Lead Agency and to make a negative declaration on the EAF. Pat Holenbeck made the motion, seconded by Linda Viney 4-0.

**Pat Holenbeck** made the motion to accept the Site Plan Review as presented for new building construction (approx. 52' x 100') 9 Upton Street, seconded by **Linda Viney** and approved 4-0.
